Hi Rob & John,

There was a suggestion at our last meeting that John would shed more light on the interpretation of the ppv results for building construction.

I recall that we were informed of the following either verbally or by email, by both Rob Bell and Craig Roubin.

1. The Mt Cootha quarry maximum allowable vibration is 10mm/sec peak particle velocity.

2. Blasts are carried out approximately monthly (on average), but may be more common if blast vibration levels were decreased.

3. A ppv of 10mm/sec for a few seconds per month is not considered harmful for buildings.

Whilst we thank you for this information, unfortunately emails have recently been discredited as a legally valid communication.

Hence we need:

 A signed letter from the council stating their maximum allowable vibration and the likely blasting requirements.
 As vibration transmission is often attenuated due to solid angle and geological strata ducting, the letter must state at what point this vibration reading applies, otherwise any numeric level is totally undefined and hence meaningless.

3. A written interpretation or professional opinion on the effects of 10mm/sec ppv on constructed buildings.

Please note that we have no personal objection to the quarry continuing its operation into the future, as long as our structural engineering constraints can be determined and finalised beyond question. The financial investment in our home construction must not be reduced by structural damage from quarry blasting.

The problem that we are having is that no structural engineer will currently touch this job, because of the blast vibrations.

It is essential that somebody indicates some research or Australian Standard accepted practice documents showing that 10mm/sec ppv does not cause harm to strong buildings.

2. We have started our granny flat construction, however re-design of the main 4 level building is waiting on an assessment by our engineers on the level of blast vibration.

EPA:

I was previously unaware that you had any limits, our engineers are asking for a maximum vibration level as ours is believed to be the only close building that is founded on bedrock.

Hence we they are very interested to know what the limits are and how these would be affected if the blast was located at its closest point.
