**Application under the *Right to Information Act 2009***

I refer to your application received by the Department of Environment and Heritage Protection (EHP) on 15 November 2013 seeking access under the *Right to Information Act 2009* (Qld)(RTI Act) to:

*'Details and contents of all blast vibration, noise and dust monitoring as supplied by the Mt Coot-tha Quarry to EHP under the terms of their DA.*

*Period: 1 January 2012 - 15 November 2013*

As required under section 24(2)(d) of the RTI Act, you identified yourself as seeking to use or benefit from access to the document/s.

- information which may be defamatory;
